Delivering medications from glass vials with syringes and/or obsolete auto-injectors is not optimal in pre-hospital and austere environments.



First responders must often save patients and deliver medication in difficult, hazardous, or chaotic locations: on battlefields, urban streets, crime scenes, mass casualty events, riots, in a desert, the Arctic, at sea, in jungles, et al.

Affordable Naloxone is Running Out, Creating a Perfect Storm for More Overdose Deaths, Activists Say August 11, 2021

An affordable antidote for opioid overdoses has become more difficult to obtain amid a fatal epidemic, in what advocates have called a "perfect storm" with **deadly consequences**.

- Organizers say the **insufficient supply** has been felt unequally **across the country.**

- Estimated that the **250,000-dose [naloxone] backorder** so far could result in at least **11,000 overdose deaths**.

The past year [2021] has already topped records for **drug overdoses**, **more than 93,000**, with opioids and the deadly synthetic opioid **fentanyl** driving the death toll, according to preliminary data from the Centers for Disease Control and Prevention. **Overdose deaths involving opioids surpassed 69,000 in 2020.**

FENTANYL OVERDOSES have surged to be the leading cause of death for adults between the ages of 18 and 45, according to an analysis of U.S. government data.

For 12 Months ending July 2022 107,000 <u>deaths</u> from drug overdoses – largely opioids.







Dear Frank.

This Letter of Intent (LOI) proposes a partnership between North American Rescue, LLC (NAR) and Action Medical Technologies, LLC (AMT). This LOI expresses the commitments of the parties. It will be followed with a Distribution Agreement allowing NAR to exclusively sell the AMT Ketamine Injector to the U.S. Department of Defense (DoD) for the first 24-36 months after product launch, and to sell other AMT highly innovative injector platform technologies filled with various generic medications (e.g. epinephrine, naloxone, anti-chemical and biological warfare weapons, emergency medical medicines, etc.) to DoD, other U.S. government agencies, NATO and other allied nation's militaries, as well as Emergency Medical Services (EMS), and medical clinic/ hospital-based customers. This will include human and veterinary medications and range from emergency field medicines to medical and dental crash-carts as well as all hospital medical applications.

NAR will provide reasonable support to AMT to help it secure \$10 million or more in non-dilutive funding, in graduating steps, for the AMT Ketamine Injector and for other drugs used in the AMT injector technologies. NAR's support will include subject matter expertise and consultation from former U.S. Special Operations Combat Medics, assistance with seeking and navigating through various funding sources' processes, connection to NAR's extensive network of DoD and U.S. and allied government agencies' contacts, and facilitation of meetings/ product demonstrations with key decision makers and strategic clients within NAR's broad customer

It is also NAR's intent to fully leverage its first-in-class distribution capabilities and highly respected NAR brand to help AMT bring their injector devices to millions of customers worldwide. NAR is very excited and committed to supporting AMT in their pursuit of funding and ultimately, global distribution of their highly innovative lifesaving product. For years, NAR has heard the voice of the warfighter ask for a reliable, durable, and intuitive auto injector device to deliver analgesia and other critically needed medications on the battlefield. Until now, no other manufacturer has brought a viable solution to the mark t that meets the arduous requirements seen in combat or other austere environments. NAR recognizes AMT and their device as the right solution for the need and is proud to be partnered with this organization and aligned with the vision of their leadership.
